## 2026 Camp Ramsbottom Scholarship Guidelines:

### Required forms/documentation:

- ✓ A current Boys & Girls Club of Pawtucket Membership, valid through the camp session you wish to register
- ✓ Proof of Residency: May include items listed below
  - Utility bill (preferred)
  - Lease
  - Notarized letter confirming the residence
  - Rental receipts confirming the residence
  - Mortgage statements including the address of residence
- ✓ Proof of Income: May include items listed below
  - 2025 Tax returns must show the child(ren) receiving the scholarship as a dependent (a copy will be kept on file by the Club). The “adjusted gross income” line will be reviewed to determine eligible household income
  - Public assistance statement with year-to-date earnings.
- ✓ \$25 Application Fee

### 2026 Scholarship Income Eligibility Requirements

We have different scholarship options available. Review the household size and income guidelines below to see if you qualify for a Camp Ramsbottom scholarship. **Lunch** is included with all scholarships; please check off the designated box on the registration form to secure a lunch for your child. In order to apply for a scholarship, you will need to apply at the Club in-person, bring proof of residency, and proof of your income.

#### Steps to verify scholarship eligibility:

1. Find the number of people in your household.
2. Find the income level which matches that of your combined household income.
3. If your combined household income is within the guidelines listed below the number of people in your household, your income qualifies you for that selected scholarship.

#### Full Scholarship:

*You must be a resident of Rhode Island or Massachusetts. Your income qualifies for this scholarship if:*

***This is a partial scholarship – you are responsible for 50% of the Campership fee (\$280/session), the membership fee, and the \$25 Scholarship Application fee. A \$75 deposit is due at the time of registration; the remaining balance must be paid 2 weeks prior to your session.***
